1 INTRODUCTION

Within the context of the international emergency situation and contextualized in a public health regime, and with reference to the provisions issued on the subject, this protocol is adopted for the containment of the diffusion of SarsCoV-2 during the Cremona Musica event. Cremonafiore has identified its RSPP (Mr. Orgiu Fabio) as covid manager for the events for which Cremonafiore itself is the organizer / manager.

The measures envisaged and / or indicated in this protocol may be subject to changes following any new indications and / or Ministerial regulations

2 GENERAL RULES

All people involved in the Cremona Musica event (CremonaFiere staff, CremonaFiere collaborators, exhibitors, visitors, etc.) are obliged to respect the general rules:

- stay at home in the presence of fever (over 37.5 ° C) or other flu symptoms
- for those who, in the last 14 days, have had contact with subjects who were tested positive for COVID-19, access to the Cremona Musica event is prohibited;
- commitment to comply with all the provisions of the Authorities and CremonaFiere in participating in the Cremona Musica event;
- wear the protective mask correctly, paying attention to cover the nose and mouth;
- frequently sanitize hands with hydroalcoholic gels distributed in the various areas;
- keep the interpersonal distance of AT LEAST 1 meter at any time and / or circumstance.

3 COMPULSORY HYGIENIC-SANITARY PRINCIPLES

The organizational model for events / exhibition cannot disregard the basic and important health principles listed below:

- **GENERAL INFORMATION:** distributed at the time of registration and posted in several places in the event area.
- **INTERPERSONAL DISTANCE:** all activities at the Show must ensure compliance with the rule that people are at least ONE METER away from each other. In common areas and in those with the greatest risk of crowding, guide signs are provided to manage crowding while maintaining the spacing.
- **USE OF PPE AND DISINFECTANT GEL:**
 - ✓ *respiratory protection masks is mandatory for everyone and always correctly worn indoors and in case of gatherings even outdoors;*
 - ✓ *hand sanitizing gels distributed in several points of the Exhibition area located where they are easily accessible by users.*

- **ENTRANCE CONTROLS:** the following control methods are applied to all those entering the exhibition center:
 - ✓ *body temperature detection with contactless systems before accessing the exhibition center;*
 - ✓ *verification of possession and validity of the "green pass" or equivalent certification⁽¹⁾;*
 - ✓ *registration of user entry and storage of information in a specific database for 14 days;*
 - ✓ *CremonaFiere gives the possibility to carry out swabs in a structure adjacent to the exhibition center, and then through the quick swab to obtain the Green Pass useful for the access to the event. For guests and exhibitors it is possible to carry out, upon reservation, the molecular swab if your country requires it to be carried out for return.*

- **MONITORING DURING THE EVENT / EXHIBITION:** the monitoring of the area is guaranteed (with particular attention to the "indoor" areas) by personnel assigned to the control (previously trained and officially in charge) to verify the correct use of the masks as well as the correct interpersonal spacing and the application of all measures to contain the spread of the virus.

- **ENVIRONMENTAL CLEANING AND SANITIZATION:** all cleaning and sanitizing operations, performed by anyone, are carried out with products that comply with the standards and / or regulations in force. The activities concern:
 - ✓ *cleaning and sanitizing before and after the event of all areas, environments and furnishings;*
 - ✓ *cleaning and sanitizing the common areas and toilets during the event; for the toilets it is guaranteed AT LEAST hourly;*
 - ✓ *ventilation of the premises (with inhibition of air recirculation) and opening of doors and / or windows.*

- **COVID-19 MEDICAL DEVICE:** there is a room used for the management of positive and / or positive Covid-19 suspects with the aim of temporarily isolating them correctly. The area is available to trained personnel and equipped with all the necessary equipment / devices.

- **MANAGEMENT OF POSITIVE COVID CASES:** indications are given on the management of positive cases ascertained during the event:
 - ✓ *for positives in need of hospital care / hospitalization, reference is made to local health facilities (ASST - ATS);*
 - ✓ *for positive symptomatic and / or asymptomatic patients not in need of hospital care / hospitalization who cannot return to their home and / or their host structure, it will be possible to spend the quarantine period at "Adriano Community Center" (tel. 800 208989), to which an entry request must be made.*

¹ - Negative result in the molecular / antigen test carried out in the 48 hours prior to the date of entry into the Exhibition Area [ita / eng]

- Certification [ita / eng] of completion of the vaccination cycle or at least 2 weeks after inoculation of the first dose.

- Certificate [ita / eng] of complete recovery after the infection from CoViD-19 (valid 180 days from the date of termination of the disease reported on the certificate).
